Subject: Charlotte Court House, VA (DMS10) Switch Retirement

PLEASE NOTE:

- All references to the Charlotte Court House VA DMS10 switch are associated with CLLI code CCHSVAXADS0 and will not be repeated throughout the notice.
- All references to the Emporia VA DMS100 switch are associated with CLLI code EMPRVAXADS0 and will not be repeated throughout the notice.

As set out in the Verizon Virginia LLC "Short Term Public Notice Under Rule 51.333(a)," dated February 8, 2022, on or after November 1, 2022, the Charlotte Court House VA DMS10 switch will be retired and removed from the Verizon network.

General Information: The Charlotte Court House VA DMS10 switch will be replaced by the Emporia VA DMS100 switch. See details in Table A.

The Exchange code (434) in Numbering Plan Area (542) currently residing in the Charlotte Court House VA DMS10 switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) on or after November 1, 2022.

Network Changes and Trunk Rearrangements:

The Emporia VA DMS100 switch will be the recipient office of traffic migrated from the Charlotte Court House VA DMS10 switch. Traffic to be migrated to the Emporia VA DMS100 switch includes all of the traffic currently handled by the Charlotte Court House VA DMS10 switch including, but not limited to, Inter-LATA access traffic (including Feature Group B and D traffic), and Intra-LATA and local traffic (including CLEC, IEC, wireless and Verizon sector end office switched traffic). After all traffic is migrated off of the Charlotte Court House VA DMS10, this switch will be retired and removed from the network.

All CLECs, IXCs, IECs, ILEC, wireless carriers and paging carriers will need to provision new trunk groups to support direct end office trunking to the Emporia VA DMS100 switch. Carriers with existing trunk groups to this switch will need to augment if necessary.

All ASRs for the Emporia VA DMS100 switch must be received no later than **September 7, 2022** in order to provide sufficient time to migrate the traffic described above. All traffic must be moved on or after **November 1, 2022** based on LERG change notification. ASRs for the Emporia VA DMS100 switch must carry the project code of **CCHSVAXARS0**.

Upon decommissioning of the **Charlotte Court House VA DMS10 switch**, the one (1) native code (NPA NXX) that currently resides in **the Charlotte Court House VA DMS10 switch** will reflect the Emporia VA DMS100 switch in the LERG.

Submission of disconnect ASRs to Verizon for the Charlotte Court House VA DMS10 switch are required immediately after the re-homing of traffic is complete.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Charlotte Court House VA DMS10 switch.
