Subject: Verizon Partner Solutions Industry Letter: Albany NY CS2K Switch Retirement

PLEASE NOTE:

- •All references to the Albany NY CS2K switch are associated with CLLI code ALBYNYSSPS0 and will not be repeated throughout this letter.
- •All references to the Albany NY C20 switch are associated with CLLI code ALBYNYSSPS1 and will not be repeated throughout this letter.

As set out in the Verizon New York. Public Notice of Network Change under Rule 51.329(a), dated July 15, 2022, on or after March 4, 2023, the Albany NY CS2K switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 518 currently residing in the Albany NY CS2K switch **(see list in Table B below)** will be moved to the Albany NY C20 switch (see details in Table A below).

The native NPA NXXs belonging to the Albany NY CS2K switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Albany NY C20 switch. This will occur on or after March 4, 2023.

Network Changes and Trunk Rearrangements:

The Albany NY C20 switch will be the recipient office of traffic migrated from the Albany NY CS2K switch. Traffic bound for the codes listed in Table B will be delivered via the Albany NY Tandem (ALBYNYSS5GT intra-lata SHA / ALBYNYSS5GT inter-lata FG Access SHA).

After all traffic is migrated off of the Albany NY CS2K, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Albany NY C20 switch. Carriers that have direct end office trunk (DEOT) with access connectivity in the Albany NY CS2K switch will be required to reposition the codes to the Albany NY C20 switch.

All ASRs for the Albany NY C20 switch must be received no later than January 1, 2023 to provide sufficient time to migrate the traffic described above. All traffic must be moved by March 4, 2023. All ASRs for the Albany NY C20 switch must carry the project code of **ALBYNYSSPS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXX codes subject to the retirement of the Albany NY CS2K switch.
