Subject : Verizon Partner Solutions Industry Letter: Robinson Township PA 5ESS Switch Retirement

PLEASE NOTE:

• All references to the Robinson Township PA 5ESS switch are associated with CLLI code RBTPPARTDS0 and will not be repeated throughout this letter.

•All references to the Oakland PA CS2K switch are associated with CLLI code PITBPAOKPS0 and will not be repeated throughout this letter.

As set out in the Verizon Pennsylvania LLC Public Notice of Network Change Under Rule 51.329(a), dated September 1, 2022, on or after April 3, 2023, the Robinson Township PA 5ESS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Areas (NPA) 412 currently residing in the Robinson Township PA 5ESS switch (see list in Table B below) will be moved to the Oakland PA CS2K switch (see details in Table A below).

The nine (9) native NPA NXXs belonging to the Robinson Township PA 5ESS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Oakland PA CS2K switch. This will occur on or after April 3, 2023.

Network Changes and Trunk Rearrangements:

The Oakland PA CS2K switch will be the recipient office of traffic migrated from the Robinson Township PA 5ESS switch. Traffic bound for the codes listed in Table B will be delivered via the Oakland GT0 Tandem (PITBPAOKGT0).

After all traffic is migrated off of the Robinson Township PA 5ESS switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Oakland PA CS2K switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Robinson Township PA 5ESS switch will be required to reposition the codes to the Oakland PA CS2K switch.

All ASRs for the Oakland PA CS2K switch must be received no later than March 2, 2023 to provide sufficient time to migrate the traffic described above. All traffic must be moved by April 3, 2023. All ASRs for the Oakland PA CS2K switch must carry the project code of **RBTPPARTDS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Robinson Township PA 5ESS switch.
