Subject : Verizon Partner Solutions Industry Letter: New York - CARRIER NETWORK CHANGE REQUIREMENTS RESULTING FROM THE INTRODUCTION OF THE NEW 329 NUMBERING PLAN AREA ("NPA") IN THE EXISTING 845 NPA

Verizon New York Inc. (hereinafter Verizon) is publishing this letter to inform you of important actions your company will need to take in light of the upcoming introduction of the new 329 NPA in New York.

On April 14, 2022, the New York Public Service Commission approved an all-services overlay as the relief method for the 845 NPA. The 845 NPA is in the southeastern portion of New York and serves all or parts of Columbia, Delaware, Dutchess, Greene, Orange, Putnam, Rockland, Sullivan, and Ulster counties, including a 12 portion of Westchester County. The new 329 NPA will serve the same geographic area currently served by the existing 845 NPA.

Network Change Requirements

The introduction of the new 329 NPA may present additional network requirements for reaching **E911**. If you are not presently utilizing SS7 trunking for E911 in the 845 NPA, you must either convert your network to utilize SS7 signaling or establish additional, unique Multi Frequency Centralized Automatic Message Accounting (MF CAMA) trunks for the new 329 NPA to distinguish between E911 calls from the existing 845 NPA and E911 calls from the new 329 NPA. Failure to address these changes may result in the inability of calls to complete to E911 call centers.

In addition, carriers currently utilizing MF CAMA trunks in the 845 NPA and intending to use Verizon's **Operator Services** (**OS**) or **Directory Assistance (DA)** in the new 329 NPA must provide separate trunk groups in their OS/DA network for the new 329 NPA. New trunks for OS or DA will be required to serve all customers using the new 329 NPA. These trunks can be ordered now through normal ordering procedures, and required testing of these trunks must be completed prior to the Network Completion date of <u>February 24, 2023</u>. Failure to address these changes may result in the inability of calls to complete to the OS/DA network.

Additional General Information

All carriers providing local exchange services in the 845 NPA region are being directed to complete their network preparation for the new 329 NPA by **February 24, 2023**. The 845/329 Area Code Relief Plan will not affect rates or local calling areas. No existing numbers will change; all numbers will retain their current NPA.

Since the 845 NPA region has 10-digit local dialing in effect, a permissive dialing period is not necessary for the 845/329 NPA Overlay implementation. Below is a summary of the current dialing plan for the 845 NPA which will continue as the new 329 NPA is implemented:

| Type of call | Call terminating in | Dialing plan |
|--|--|----------------------------------|
| Local &Toll Calls | Overlay Home NPAs (HNPA) (Within and between the 845 and 329 NPAs) | I 10-digits (NPA-NXX-XXXX)* |
| Local &Toll Calls | Foreign NPA (FNPA) outside of overlay NPAs | 1 + 10-digits (1 + NPA-NXX-XXXX) |
| Operator Services Credit card, collect, third party party | HNPA or FNPA | 0 + 10-digits (0 + NPA-NXX-XXXX) |

*1+10 digit dialing for all calls permissible at each service providers discretion.

New telephone lines or services activated on or after March 24, 2023 may be assigned numbers with the new 329 NPA. Activation of the new 329 NPA will not result in any changes in Verizon rates or local calling areas.

Verizon will launch customer education plans providing information related to the NY 845/329 NPA Overlay. Consumer information regarding this Area Code Relief Plan and others throughout the Verizon Region is available at verizon.com/areacodes.
