## Subject : Verizon Partner Solutions Industry Letter: East Greenwich RI DMS100 Switch Retirement

## PLEASE NOTE:

• All references to the East Greenwich, RI DMS100 switch are associated with CLLI code EGRNRICHDS0 and will not be repeated throughout this letter.

•All references to the Providence, RI Packet End Office (PEO) switch are associated with CLLI code PRVDRIWAPS0 and will not be repeated throughout this letter.

As set out in the Verizon New England Inc. Short Term Public Notice Under Rule 51.333(a), dated November 1, 2022, on or after January 3, 2023, the East Greenwich, RI DMS100 switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 401 currently residing in the East Greenwich, RI DMS100 switch (see list in Table B below) will be moved to the Providence, RI PEO switch (see details in Table A below).

The native NPA NXXs belonging to the East Greenwich, RI DMS100 switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Providence, RI PEO switch. This will occur on or after January 3, 2023.

The Providence, RI PEO switch will be the recipient office of traffic migrated from the East Greenwich, RI DMS100 switch. Traffic bound for the codes listed in Table B will be delivered via the Providence, RI Tandem (PRVDRIWA06T intra-lata SHA / PRVDRIWA06T inter-lata FG Access SHA).

After all traffic is migrated off of the East Greenwich, RI DMS100 switch, it will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Providence, RI PEO switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the East Greenwich, RI DMS100 switch will be required to reposition the codes to the Providence, RI PEO switch.

All ASRs for the Providence, RI PEO switch must be received no later than December 2, 2022, to provide sufficient time to migrate the traffic described above. All traffic must be moved by January 3, 2023. All ASRs for the Providence, RI PEO switch must carry the project code of **EGRNRICHDS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the East Greenwich, RI DMS100 switch.
