## Subject : Verizon Partner Solutions Industry Letter: West 36 Street NY Switch Retirement

## PLEASE NOTE:

• All references to the West 36th Street NY DMS switch are associated with CLLI code NYCMNY36DS0 and will not be repeated throughout this letter.

•All references to the Pearl Street NY C20 switch are associated with CLLI code NYCMNYPSPS1 and will not be repeated throughout this letter.

As set out in the Verizon New York Public Notice of Network Change under Rule 51.329(a), dated January 3, 2023, on or after December 1, 2023, the West 36th Street NY DMS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 212, 646, and 917 currently residing in the West 36th Street NY DMS switch (see list in Table B below) will be moved to the Pearl Street NY C20 switch (see details in Table A below).

The native NPA NXXs belonging to the West 36th Street NY DMS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Pearl Street NY C20 switch. This will occur on or after December 1, 2023.

## **Network Changes and Trunk Rearrangements:**

The Pearl Street NY C20 switch will be the recipient office of traffic migrated from the West 36th Street NY DMS switch. Traffic bound for the codes listed in Table B will be delivered via the 13th Street NY 06T 5E tandem local and LD FG (NYCMNY1306T intra-lata SHA / inter-lata FG Access SHA).

After all traffic is migrated off the West 36th Street NY DMS switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Pearl Street NY C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the West 36th Street NY DMS switch will be required to reposition the codes to the Pearl Street NY C20 switch.

All ASRs for the Pearl Street NY C20 switch must be received no later than October 1, 2023 to provide sufficient time to migrate the traffic described above. All traffic must be moved by December 1, 2023. All ASRs for the Pearl Street NY C20 switch must carry the project code of NYCMNY36DS0DS.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the West 36<sup>th</sup> Street NY DMS switch.
