Subject: Verizon Partner Solutions Industry Letter: Dobbs Ferry DMS Switch Retirement

PLEASE NOTE:

- All references to the Dobbs Ferry NY DMS switch are associated with CLLI code DBFYNYDFDS0 and will not be repeated throughout this letter.
- •All references to the Pleasantville NY DMS switch are associated with CLLI code PSVLNYPSPSA and will not be repeated throughout this letter.

As set out in the Verizon New York LLC Public Notice of Network Change under Rule 51.329(a), dated March 1, 2023, on or after October 2, 2023 the Dobbs Ferry DMS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Area (NPA)

914 currently residing in the Dobbs Ferry DMS switch (see list in Table B below) will be moved to the PSVLNYPVPSA switch (see details in Table A below).

The native NPA NXXs belonging to the Dobbs Ferry DMS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the PSVLNYPVPSA switch. This will occur on or after October 2, 2023.

The Pleasantville DMS switch will be the recipient office of traffic migrated from the Dobbs Ferry DMS switch. Traffic bound for the code listed in Table B will be delivered via the White Plains 08T Tandem (WHPLNYWP08T intra-lata SHA / WHPLNYWP08T inter-lata FG Access SHA).

After all traffic is migrated off of the Dobbs Ferry DMS switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Pleasantville DMS switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Dobbs Ferry DMS switch will be required to reposition the codes to the Pleasantville DMS switch.

All ASRs for the Pleasantville DMS switch must be received no later than August 1, 2023 to provide sufficient time to migrate the traffic described above. All traffic must be moved by October 2, 2023 per LERG. All ASRs for the Pleasantville DMS switch must carry the project code of **DBFYNYDFDS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Dobbs Ferry DMS switch.
