Subject : Verizon Partner Solutions Industry Letter: Franklin NY 5E Switch Retirement

PLEASE NOTE:

• All references to the Franklin NY 5E switch are associated with CLLI code WDMRNYFRDS0 and will not be repeated throughout this letter.

•All references to the Williamsburg NY C20 switch are associated with CLLI code NYCKNYWMPS1 and will not be repeated throughout this letter.

As set out in the Verizon New York Inc. Public Notice Under Rule 51.329(a), dated November 15, 2023, on or after July 1, 2024, the Franklin NY 5E switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 516 currently residing in the Franklin NY 5E switch (see list in Table B below) will be moved to the Williamsburg NY C20 switch (see details in Table A below).

The native NPA NXXs belonging to the Franklin NY 5E switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Williamsburg NY C20 switch. This will occur on or after July 1, 2024.

Network Changes and Trunk Rearrangements:

The Williamsburg NY C20 switch will be the recipient office of traffic migrated from the Franklin NY 5E switch. Traffic bound for the code listed in Table B will be delivered via the Deerpark 03T Tandem (DRPKNYDP03T intra-lata and inter-lata FG Access SHA).

After all traffic is migrated off of the Franklin NY 5E switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Williamsburg NY C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Franklin NY 5E switch will be required to reposition the codes to the Williamsburg NY C20 switch.

All ASRs for the Williamsburg NY C20 switch must be received no later than May 1, 2024 to provide sufficient time to migrate the traffic described above. All traffic must be moved by July 1, 2024. All ASRs for the Williamsburg NY C20 switch must carry the project code of **WDMRNYFRDS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Franklin NY 5E switch.
