# Subject : Verizon Partner Solutions Industry Letter: Convent Avenue NY DMS Switch Retirement

### PLEASE NOTE:

• All references to the Convent Avenue NY DMS switch are associated with CLLI code NYCMNYCADS0 and will not be repeated throughout this letter.

•All references to the Pearl Street NY C20 switch are associated with CLLI code NYCMNYPSPS1 and will not be repeated throughout this letter.

As set out in the Verizon New York Public Notice of Network Change under Rule 51.329(a), dated December 13, 2023, on or after August 1, 2024, the Convent Avenue NY DMS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 212, 646 and 917 currently residing in the Convent Avenue NY DMS switch (see list in Table B below) will be moved to the Pearl Street NY C20 switch (see details in Table A below).

The native NPA NXXs belonging to the Convent Avenue NY DMS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Pearl Street NY C20 switch. This will occur on or after August 1, 2024.

#### Network Changes and Trunk Rearrangements:

The Pearl Street NY C20 switch will be the recipient office of traffic migrated from the Convent Avenue NY DMS switch. Traffic bound for the codes listed in Table B will be delivered via the 37 Street NY 23T 5E tandem local and LD FG (NYCMNY372T intralata SHA / inter-lata FG Access SHA).

After all traffic is migrated off the Convent Avenue NY DMS switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Pearl Street NY C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Convent Avenue NY DMS switch will be required to reposition the codes to the Pearl Street NY C20 switch.

All ASRs for the Pearl Street NY C20 switch must be received no later than June 1, 2024 to provide sufficient time to migrate the traffic described above. All traffic must be moved by August 1, 2024. All ASRs for the Pearl Street NY C20 switch must carry the project code of NYCMNYCADS0.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Convent Avenue NY DMS switch.
