Subject: Verizon Partner Solutions Industry Letter: Freehold VTOA Tandem (FRHDNJFHGT0/G0T)

PLEASE NOTE:

- All references to the Freehold NJ VTOA Tandem switch are associated with CLLI code FRHDNJFHGT0/G0T and will not be repeated throughout this letter.
- •All references to the New Brunswick NJ 04T Tandem switch are associated with CLLI code NBWKNJNB04T and will not be repeated throughout this letter.

As set out in the Verizon New Jersey Inc. Public Notice of Network Change Under Rule 51.329(a), dated January 31, 2024, on or after August 1, 2024, the Freehold NJ VTOA Tandem switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information:

All of the NPA/NXXs Codes subtending to the seventeen (17) end offices (see Table B below) supporting Local/Intra-Lata traffic via Freehold NJ VTOA Tandem switch will be moved to the New Brunswick NJ 04T Tandem switch (see details in Table A below). The codes will be rehomed upon decommissioning of the Freehold NJ VTOA switch and will be reflected in the Local Exchange Routing Guide (LERG) for the New Brunswick NJ 04T Tandem switch. This will occur on or after August 1, 2024.

Network Changes and Trunk Rearrangements:

The New Brunswick NJ 04T Tandem switch will be the recipient office of traffic migrated from the Freehold NJ VTOA Tandem switch. Traffic bound for the end offices listed in Table B will be delivered via the New Brunswick 04T Tandem (NBWKNJNB04T).

After all traffic is migrated off of the Freehold NJ VTOA Tandem switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the New Brunswick NJ 04T Tandem switch or have existing trunk groups to that switch augmented. Carriers that are code holders with connectivity in the Freehold NJ VTOA Tandem switch will be required to reposition the codes to the New Brunswick NJ 04T Tandem switch.

All ASRs for the New Brunswick 04T Tandem switch must be received no later than June 1, 2024 to provide sufficient time to migrate the traffic described above. All traffic must be moved by August 1, 2024. All ASRs for the New Brunswick NJ 04T Tandem switch must carry the project code of **NBWKNJNB04T**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Freehold NJ VTOA Tandem switch.
