PLEASE NOTE:

• All references to the Brookland DC 5E switch are associated with CLLI code WASHDCBKDS0 and will not be repeated throughout the notice.

• All references to the Southwest DC CS2K switch are associated with CLLI code WASHDCSWPS0 and will not be repeated throughout the notice.

Description of the Planned Network Change(s):

The Verizon Brookland DC 5E switch, located at 1039 Lawrence Street N.E., Washington, DC 20017, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Southwest DC CS2K switch, located at 30 E Street S.W., Washington, DC 20024. All traffic to be migrated to the Southwest DC CS2K switch includes, but is not limited to, inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

All carriers, including competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to provision new trunk groups to support direct end-office trunking to the Southwest DC CS2K switch or have existing trunk groups to that switch augmented.

All ASRs for the Southwest DC CS2K must be received no later than May 22, 2023 to provide sufficient time to migrate the traffic described above. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Brookland DC 5E switch (on or after July 3, 2023). This will serve to guide interconnect re-routes of traffic for the NPA codes currently served by the Brookland DC 5E switch to reflect the Southwest DC CS2K switch as the new home switch. All trunks to the Southwest DC CS2K switch must be in place prior to the decommissioning of the Brookland DC 5E switch. All ASRs for the Southwest DC CS2K switch must carry a project code of WASHDCBKRP0.
