# **Description of the Planned Network Change(s):**

The Verizon Covent Avenue NY DMS switch, located at 380 Convent Avenue, New York, NY 10031, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Pearl Street NY C20 switch, located at 375 Pearl Street, New York, NY 10038. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-BD/CLEC/IXC), wireless, and paging traffic.

# Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Pearl Street NY C20 switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Convent Avenue NY DMS switch will be required to reposition the codes to the Pearl Street NY C20 switch.

All ASRs for the Pearl Street NY C20 switch must be received no later than June 1, 2024 to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Convent Avenue NY DMS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change

effective dates will be posted prior to decommissioning of the Convent Avenue NY DMS switch ( <b>on or af</b> This will serve to guide interconnect re-routes of traffic for the twelve (12) native codes currently served be Avenue NY DMS switch to reflect the Pearl Street NY C20 switch as the new home switch. All ASRs for the C20 switch must carry the project code of NYCMNYCADS0.	by the Convent
