## PLEASE NOTE:

- All references to the South Schenectady, NY DMS100 switch are associated with CLLI code SSCHNYSODS0 and will not be repeated throughout this notice.
- All references to the Albany, NY Packet End Office (PEO) switch are associated with CLLI code ALBYNYSSPS1 and will not be repeated throughout this notice.

## **Description of the Planned Network Change(s):**

The Verizon South Schenectady, NY DMS100 switch, located at 1966 Curry Road, South Schenectady, NY 12303, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Albany, NY PEO switch, located at 158 State Street, Albany, NY 12207. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

## Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Albany, NY PEO switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the South Schenectady, NY DMS100 switch will be required to reposition the codes to the Albany, NY PEO switch.

All ASRs for the Albany, NY PEO switch must be received no later than November 15, 2024 to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the South Schenectady, NY DMS100 switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the South Schenectady, NY DMS100 switch (on or after January 2, 2025). This will serve to guide interconnect re-routes of traffic for the five (5) native codes currently served by the South Schenectady, NY DMS100 switch to reflect the Albany, NY PEO switch as the new home switch. All ASRs for the Albany, NY PEO switch must carry the project code of SSCHNYSODS0.
