PLEASE NOTE:

- All references to the Aberdeen Road VA 5E switch are associated with CLLI code HMPNVAABDS0 and will not be repeated throughout the notice.
- All references to the Chinese Corner VA CS2K switch are associated with CLLI code VRBHVACCPS0 and will not be repeated throughout the notice.

Description of the Planned Network Change(s):

The Verizon Aberdeen Road VA 5E switch, located at 1606 Aberdeen Road, Hampton, VA 23666, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Chinese Corner VA CS2K switch, located at 221 Dorsett Avenue, Virginia Beach, VA 23462. All traffic to be migrated to the Chinese Corner VA CS2K switch includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

All carriers, including competitive local exchange carriers (CLECs), Interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers, will need to provision new trunk groups to support direct end office trunking to the Chinese Corner VA CS2K switch or have existing trunk groups to that switch augmented.

All ASRs for the Chinese Corner VA CS2K switch must be received no later than **November 14, 2024** to provide sufficient time to migrate the traffic described above. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Aberdeen Road VA 5E switch (**on or after January 2, 2025**). This will serve to guide interconnect re-routes of traffic for the NPA codes currently served by the Aberdeen Road VA 5E switch to reflect the Chinese Corner VA CS2K switch as the new home switch. All trunks to the Chinese Corner VA CS2K switch must be in place prior to the decommissioning of the Aberdeen Road VA 5E switch. All ASRs for the Chinese Corner VA CS2K switch must carry a project code of **HMPNVAABDS0**.
