

**ID provided as verification of identity must be an exact match to the bill name on the application for service with Verizon. The ID must be current, valid and unaltered.**

<b>Learner's Permit</b>	Must be current, valid and issued in the USA. Can not combine with regular driver's license, State ID Card or International Driver's License	PHOTO
<b>NY Driver's License with MV/2168 Address Correction Sticker</b>	Must be current, valid NY Driver's License with change of address sticker on the front. Can not combine with Learner's Permit, State ID Card or International Driver's License.	PHOTO
<b>Massachusetts Liquor ID Card</b>	Applicant must be at least 21 years of age. May not be combined with a Massachusetts DL, Learner's Permit, International Driver's License or a Driver's License issued by any other state, State ID Card or Mass ID Card. Must be a resident of Massachusetts.	PHOTO
<b>Massachusetts ID Card</b>	Applicant must be at least 18 years of age. May not be combined with a Massachusetts DL, Learner's Permit, International Driver's License or a Driver's License issued by any other state, State ID Card or Mass Liquor ID Card. Must be a resident of Massachusetts.	PHOTO
<b>International Driver's License</b>	Must be obtained in the applicant's home country. Must be current / valid.	PHOTO
<b>Passport</b>	Must be current/valid and include applicant's legal name, date of birth, date of issue and expiration date and country of origin.	PHOTO
<b>Immigration / Naturalization ID</b>	Must be current/valid and contain legal name of applicant.	PHOTO
<b>Permanent Resident Card</b>	Must include name, DOB, gender, country of birth.	PHOTO
<b>Certificate of Citizenship</b>	Must be current/valid and contain legal name of applicant.	PHOTO
<b>U. S. Visa</b>	Must Include bearer's surname, given name, passport number, gender, DOB & nationality, date of issue and expiration date.	PHOTO
<b>Military ID</b>	Military status can be Active Duty, Retiree, Reservist or Dependent.	PHOTO
<b>Veteran's Identification Card</b>	Must provide a copy of the front & back of card	PHOTO
<b>State ID Card</b>	State issued identification card. Must be current/valid and contain legal name of applicant.	PHOTO
<b>Employment Authorization Card</b>	Must include bearer's fingerprint card #, DOB, country of origin, date of issue and expiration dates.	PHOTO
<b>Matricula Consular</b>	Contains the bearer's name, date & place of birth, signature & photo. <b>Cards issued prior to March 2002 will not be accepted.</b>	PHOTO
<b>Cédula</b>	Must include name, DOB, place of birth, gender, signature date of issuance & expiration date.	PHOTO

Birth Certificate	Must include applicant's name, DOB, gender, place of birth. Must have stamp/seal. Must also provide legal documentation supporting a name change (example: Marriage certificate, legal name change document)	NON-PHOTO
Birth Certificate Transcript	Must include the same information as a birth certificate, including stamp/seal. Must also provide legal documentation supporting a name change (example: Marriage certificate, legal name change document)	NON-PHOTO
Major Credit Card Statement	Must be dated within the past 30 days and linked to the current or previous address. Can only accept 1 item from this category. (It is not necessary to include the account number)	NON-PHOTO
Bank Statement	Must include applicant's name & address, dated within the past 30 days and linked to current or previous address. Can not combine with credit card statement. Can only accept 1 item from this category, can only accept statement from 1 bank or lending institution. Can not combine with credit card bill. (It is not necessary to include the account number)	NON-PHOTO
Letter from Utility	Will accept letter from Utility on company letterhead with contact name & number. Must include applicant's name and address where customer held service.	NON-PHOTO
Utility Bill	Any utility or cellular telephone statement, with applicant's full legal name, linked to current or previous address and issued with the past 30 days. NOTE:We do not accept any Verizon bills as acceptable ID. This includes telecom, wireless, broadband, HSI, Data or FiOS.	NON-PHOTO
County ID	Must include applicant's name, name of county & state.	NON-PHOTO
DD214 Military Discharge Document	May be used in conjunction with Military ID.	NON-PHOTO
Payroll Check Stub	Applicant's full legal name, minimum last 4 of SSN, & issued within the last 30 days. Must include name of business/employer. May not combine with employee/company ID or Professional License. <b>Do not select payroll check stub as a non-photo ID if you have not provided your Social Security Number</b>	NON-PHOTO
Professional License	Must be issued by a state or federal agency. Can not be expired. May accept in conjunction with Employee ID. May not combine with pay stub.	NON-PHOTO
Employee/Company ID	Must include name of company/employer. May accept in conjunction with Professional License. May combine with pay stub if SSN has been provided. (See Social Security Card)	NON-PHOTO
Medical Insurance Card	Includes Medical Card, Medicare, Medicaid, PA Access Card, State Issued Welfare/Benefit Card - Must provide a copy of front & back of card and include bill name/applicant name. Can only accept 1 item from this category.	NON-PHOTO
EBT Card	<b>Electronic Benefit Transfer</b> - Must include applicant's name	NON-PHOTO

Mortgage or Deed	Must include the new service address. Will also accept the realtor's/seller's sales agreement that includes the new address	NON-PHOTO
Notarized Lease	<b>Must be notarized</b> and include applicant's name, address, landlord name or leasing corp and dates.	NON-PHOTO
W2 & 1099 Tax Forms	Must be computer generated/typed. No hand written entries. <b>(1040 FORM not considered valid form of ID)</b>	NON-PHOTO
4029 Tax Form	Must have an approval stamp from the IRS.	NON-PHOTO
Tax ID Card	May provide a copy of either an ITIN - (Individual Taxpayer Identification Number) or EIN (Employer Identification Number) Card.	NON-PHOTO
Auto Insurance Card	Must be valid/current insurance card with applicant's full legal name. Must link to current or previous address. Not necessary to provide a copy of the policy	NON-PHOTO
Tribal ID - Native American ID Card	Must be issued by Federally Recognized Tribe. Front: Must include name of tribe, applicant's name and picture. Must provide a copy of the front and back of card.	NON-PHOTO
TPS Card	<b>Temporary Protected Status</b> - Must include applicant's name	NON-PHOTO
Exchange Visitor Visa	Certificate of Eligibility for Exchange Visitor Status. Must be stamped with a Duration of Stay status.	NON-PHOTO
Refugee Settlement Placement Form	Will accept the following 2 forms of ID from Refugee Placement applicants <b>ONLY</b> : Reception and Placement Assurance Form & I-94 Papers. Can only accept for applicants who are sponsored through an approved resettlement program.	NON-PHOTO
Student ID	Must include applicant's name, and Name of school. Must be valid for current school year. High school ID must be accompanied by a Birth Certificate.	NON-PHOTO
Emancipation Papers	Must include applicant's name, court stamp/seal.	NON-PHOTO
Parole Identification	Must be authorized by the parole office or parole officer. Must be written on official letterhead or stationary and signed by the probation officer. Can use as primary ID if applicant is in the process of being paroled and has no other valid ID	NON-PHOTO
Social Security Card	Must include Applicant's name. Must also provide legal documentation supporting a name change (example: Marriage certificate, legal name change document.) <b>Do not select social security card as a non-photo ID if you have not provided your social security number.</b> <b>Non Photo</b>	NON-PHOTO
