(Mary Reynolds): Thank you, Frank. Good afternoon, everyone. For the CT update today, I would just like to go over some important updates for the upcoming June CTE release. For those that have elected to test CTE for June, your test plans were due yesterday, Monday, May 12th.

It's not too late to still submit them if you have not already done so. The CTE environment will be down on Friday, May 23 for the June code install. Due to the Memorial Day holiday on Monday, May 26, testing will begin on Tuesday, May 27. Testing will then end on Thursday, June 19 and production will be updated on Monday, June 3 with that code.

These dates can also be found on the CTE East and West home pages by selecting the release schedule length on the right-hand side of the page. That's all I have for today. Are there any questions?
